Forty-six classes are being offered on just about any topic imaginable. In addition, students are given the opportunity to select from a wide variety of optional side trips to supplement the numismatic activities of the week. If you are unable to attend the summer seminar, the ANA's 109th Annual Convention will be held in Philadelphia from August 9-13. Five days of non-stop numismatic action between the bourse, auctions, specialty club meetings, and the numismatic theatre.

Finally, preparations are currently underway for the PNNA's 2001 Convention. The convention is currently scheduled for May 4-6, 2001 at a community facility in Tukwila and will give us easy access from the airport as well as Seattle and the surrounding communities. It should be a great show and will hopefully attract several national dealers who have been looking for a venue in the Seattle market.

PNNA Turns 25 In ANA

The PNNA will receive a plaque for 25 years' membership in the ANA at the Philadelphia convention in August. Of course, the PNNA is much older than that (we turn 60 this year). Two members remain with charter membership numbers: Les Copan and Mary Fray.

A show committee is working to conduct the 2001 convention in the Tukwila Community Center, a new facility that looks like it will make a good venue. State Quarters Report

One reads quite a bit of conflicting information about what is "findable" and what is not when looking for the State Quarters. I decided to conduct a test to determine what might be found in a fixed amount of quarters. As a person who had access to coin from vending machines — and, as one who was about to retire and lose that access — I went through a bag of \$500 in quarters that had been picked up in south King

County over a three day period. The coins came from over 100 vending machines. The results are as follows:

- Only "D" minted coins appeared. Not ONE was from the Philadelphia Mint.
- Exactly \$35 in State Quarters were separated out of the bag. This is exactly 7%.
- There were 11 Delaware coins, most of them showing some circulation by now.
- There were 9 Pennsylvania quarters. These were the "toughest" to find.
- There were 10 New Jersey pieces.
- Only 3 Massachusetts quarters were found — however, they were just being issued.
- There were 12 Maryland coins, much to my surprise — the first I had seen.

Quickly adding up the above, one can see that the total is only \$12.50 of the \$35 that was collected. The remainder of the quarters were divided between the following:

- Georgia: 41 quarters, or \$10.25.
- Connecticut: 49 quarters, or \$12.25.

The conclusions are, from this grouping, that about 7 percent of the quarters you might find in a random sampling will be state quarters, all from the Denver mint. About 2.3% of the sampling were Georgia, the same for Connecticut, and the same for all the rest. This sampling will change, however, with little passage of time, as the Massachusetts and Maryland quarters become more common, and the Delaware, Pennsylvania, and New Jersey pieces are found by an ever-increasing collector base. The Georgia and Connecticut coins seem to be in no danger of disappearing from our pocket change any time soon.

ANA CONVENTION PRE-REGISTRATION GOES ON-LINE — The ANA is introducing on-line convention pre-registration with its World's Fair of Money 2000 in Philadelphia, August 9-13.

"Internet use is growing, and we thought many of those planning to attend our convention this summer would like the opportunity to pre-register for the show via our web site (www.money.org) and click on to Current Events," says Convention Services Manager Brenda Bishop. "As an incentive, we will give away to one lucky person who pre-registers on-line before July 15 a choice of either a convention banquet ticket or the convention two-medal set."

Pre-registration saves members time and money. It assures that ANA member badges are prepared and ready for pickup at the show, and that official ribbons and other requested items are included in pre-registration packets. Those who register before July 15 receive discounts on convention badges, medals, tours and banquet tickets, and special rates at ANA hotels in Philadelphia.

"We have some wonderful tours planned for the show," Bishop says, "including a historic tour of Philadelphia via trolley; a trip to the Independence Seaport Museum; special numismatic tours of the United States Mint, the Federal Reserve Bank and The Franklin Mint Museum. We also have reserved tickets for a Major League Baseball game between the Philadelphia Phillies and San Diego Padres. Everyone who purchases one or more tours will be given a special commemorative tour pass."

No purchase is necessary to enter the free drawing for the banquet ticket or medal set. All those who pre-register for the ANA World's Fair of Money through the ANA's web site will automatically be entered. The winner will be chosen at random after pre-registration ends on July 14, 2000. Members of the ANA Board of Governors, officers, staff and their immediate families are ineligible for the drawing.

The ANA has arranged for airfare discounts of 5 to 15 percent on United Airlines, the official airline for the World's Fair of Money 2000. United is offering 5-percent off the lowest applicable fare, and 10-percent off unrestricted coach fares. For reservations on the ANA's official airline to the World's Fair of Money 2000 in Philadelphia, call United Meeting Specialists at 800/521-4041 or M&M World Travel Service at 800/426-8326, and refer to Meeting ID# 581CK to obtain the appropriate discount.

Peace Exhibits at Convention — At this year's World's Fair of Money (Pennsylvania Convention Center in Philadelphia, August 9-13) a special, one-year-only competitive exhibit class will be judged for material featuring "Peace as Recorded in Numismatics."

Created by the ANA Board of Governors, with funding provided by the Lewis M. Reagan Memorial Foundation, the focus of the displays will be "Peace" and/or "The Year 2000."

According to ANA Governor Tom Hallenbeck, who proposed the idea, "The theme lends itself to a variety of interpretations, limited only by your imagination. An exhibit could feature anything from ancient coinage bearing olive branches (a recognized symbol of peace) to American Indian Peace medals or modern commemorative coins."

It's too late to enter a competitive exhibit, although the ANA may sometimes accept non-competitive exhibits on a space-available basis after the official deadline.

To maintain a corps of qualified judges who support the high standards of exhibit competition, the ANA sponsors the Judges' Familiarization and Certification Program. Those who satisfactorily complete the training are certified as ANA judges. Exhibitors who wish to learn more about the judging process also are invited to participate. ANA Chief Judge Joseph E. Boling will supervise this year's program, offered in conjunction with the ANA convention in Philadelphia. The first segment, beginning at 10:30 a.m. on Wednesday, August 9, is a procedural class in which applicants receive practice judging sheets. On Friday, August 11, participants submit the sheets for evaluation by program staff. The final session of the program is scheduled for 4 p.m. on Saturday, August 12, when participants receive the completed evaluations and notification of results.

Larry Rowe installed the new officers, and new president Scott Loos thanked the Willamette Coin Club for the good job they had done again in hosting the 2000 convention. Convention bourse chairman and WCC member Rob Retz announced that the WCC will decline to host the 2001 convention, feeling that it is time to move the convention to another geographic area.

President Loos then asked all present to get out and determine what clubs and members want the PNNA to do for them.

The meeting was adjourned at 8:36 AM.

Minutes of PNNA board meeting 22 April 2000, Portland Oregon

The meeting was called to order by President Scott Loos at 8:36 AM. Present were vice president Larry Gaye, secretary/treasurer Joe Boling, past president Tom Sheehan, directors Richard Billings, Del Cushing, Eric Holcomb, Paul Longcrier, Alex Pancheco, Larry Rowe, and Bruce Wonder, members Ken Hill, Rick Hobson, Lisa Loos, and Rob Retz, and guest George Bernert.

Moved and seconded (Wonder/Rowe) to approve the minutes of the 3 April 1999 and 15 January 2000 board meetings as published. Passed.

Moved and seconded (Billings/Longcrier) to approve the expenditure of \$650 for 10,000 generic wooden nickels advertising the PNNA. Passed. [These woods are for distribution at such locations as the Puyallup Fair. If member clubs need a supply of these woods, please contact Del Cushing.]

Moved and seconded (Sheehan/Pancheco) to continue indefinitely the present program of awards to clubs for their National Coin Week promotions (prizes of \$100, \$75, and \$50 for the three best efforts). Passed.

Moved and seconded (Holcomb/Pancheco) to allow members to use the PNNA logo on business cards and letterheads after the individuals have signed statements that they will adhere to the ANA code of ethics. Passed. This policy is to be published in *The Nor'wester*. [Officers are requested to bring such use of the PNNA logo to the attention of the secretary, who will obtain the required statements from those users.]

There was much discussion of a location for the 2001 convention. Dick Billings has visited several Seattle-eastside facilities and found them generally unreceptive without a guarantee of over 100 hotel rooms (even for the Bellevue convention space in Meydenbauer Center, which is not associated with any hotel). The Bellevue Inn may be willing to take us in; Billings and Cushing were appointed a committee to locate a venue. Loos observed that the PNNA officers may have to run the convention if no host club steps forward [and none has for several years in the Seattle-Tacoma area]. Boling assured the Willamette CC members that the cases and other PNNA equipment that they are storing would be removed as soon as the new venue is determined. The next discussion of the 2001 convention is to be at the next board meeting, 27 May at 6:30 PM (following close of the show at the La Quinta Inn, Tacoma).

Boling distributed the current month's financial report, and noted that the PNNA had spent nothing on education in 1999. Our mission requires that we put forth more effort than that; he requested that officers suggest potential projects at the next board meeting.

Moved and seconded (Rowe/Cushing) to bestow honorary life membership on Tom Sheehan in thanks for his service as PNNA president 1998-2000. Passed.

The meeting adjourned at 9:15 AM.

Minutes of PNNA board meeting

27 May 2000, Tacoma Washington

The meeting was called to order by President Scott Loos at 6:21 PM. Present were secretary/treasurer Joe Boling, directors Richard Billings, Del Cushing, Marge Farnam, Paul Longcrier, Art Lowrie, Bill McKivor, Larry Rowe, and Bruce Wonder, and members Don Farnam, Lisa Loos, and Kathy Rowe.

Moved and seconded (Rowe/Wonder) to approve the minutes of the 22 April 2000 board meeting as published. Passed.

Boling announced that the ANA has written to say that the PNNA will receive its 25-year club membership plaque at the Philadelphia convention in August, and wants to know who will receive it. President Loos will attend the awards ceremony at 1:00 PM Friday 11 August to receive the plaque.

Boling reported that the ANA has solicited convention patron donations from member clubs. Moved and seconded (Rowe/Wonder) that the PNNA donate \$100 to the ANA for the Philadelphia convention (silver sponsor level). Passed.

Boling reported that President Loos had received a letter from ANA offering 50-States quarter coin boards at about 50¢ each for distribution to potential collectors. The boards hold twenty coins (the 1999 and 2000 emissions, from the Denver and Philadelphia mints). Further boards will be forthcoming for future years' issues. Moved and seconded (Rowe/Billings) that the PNNA order eight cases (1080 boards) for distribution at Puyallup and in classroom presentations (total cost \$528). Passed.

A request for a classroom presentation has been received from a school in Fall City, Washington. Del Cushing took the information and will follow up with the teacher.

Larry Rowe announced that the National Coin Week competition is open until 31 May, and that he has received four entries to date. He will evaluate the submissions after the deadline, determine the top three efforts, and notify President Loos and Treasurer Boling (for distribution of award checks).

Del Cushing and Dick Billings have visited several potential venues for the 2001 PNNA convention. The best offer seems to be from the Tukwila municipal meeting center, which has a 10,000 square foot facility that we can get for three days for under \$3500. We will have to rent 8-foot tables (they have only about thirty, preferring to use round banquet tables that are not practical for our convention). Moved and seconded (Rowe/McKivor) that Del Cushing and Art Lowrie further investigate the suitability of that hall (particularly as regards electric power runs to tables), and finalize a reservation for early May/late April 2001 if the space is suitable; up to \$2000 authorized for a deposit. Passed.

The following show committee appointments were made: general chairman, Dick Billings; bourse chairman, Del Cushing; exhibit chairman, Larry Rowe; treasurer, Joe Boling; publicity, Art Lowrie. The general chairman will make further appointments as necessary.

Larry Rowe requested that the PNNA write to the Willamette Coin Club thanking them for hosting the PNNA conventions in 1998, 1999, and 2000 (plaques have already been presented for the years 1995, 1996, and 1997).
