The PNNA board, at the September board meeting, acted on several ideas that will have a positive impact on the collecting community here in the northwest. Here are a few of the motions that were approved for action over the next year:

PNNA Scholarship Program: Beginning with 2003, the PNNA will offer a scholarship to the ANA Summer Seminar in Colorado Springs, CO. The package will include round trip airfare, seminar tuition, and room and board on the campus of The Colorado College (approximate value of \$1,000). The winner will be either an adult or YN collector that is a member of the PNNA and completes an application indicating his/her activities/contributions to the hobby. Additional information will be listed in The Nor'Wester as it becomes available.

PNNA YN Program: The board voted to fund an additional \$1,000 to the PNNA YN Program. YN activities will again include a "Design a Quarter" program in the local schools (aimed at the 5th and 6th grade levels), and a Treasure Hunt that will take place at the PNNA convention to be held April 25-27, 2003 at the Tukwila Community Center. Signs were displayed at the PNNA table at the Puyallup Fair with contact information for classes/schools interested in participating in the quarter design program. We are also looking into beginning programs with local scouting groups.

PNNA Seminar Series: The PNNA is currently looking into starting either an annual or semi-annual seminar series starting with Fall 2003. The seminars will include U.S. and World collecting topics and will either be a two or three day format. Please look for additional information in future issues of The Nor'Wester.

Club President's Breakfast: Beginning with the 2003 PNNA convention, the breakfast will be an open forum for the Presidents/representatives of clubs in the region to come together and address issues and exchange ideas.

Club Brochure: A brochure/listing will be created that will list information on all clubs in the region and will be made available for distribution at coin shows, coin shops, the Puyallup Fair, libraries etc.

Club Sponsorship at PNNA Convention: Earn up to \$750 for your PNNA-member coin club! See 2003 convention report on page 5.

Exhibits at the 2002 ANA Convention

Because of space restrictions, only fifty-two competitive exhibits were shown at the New York ANA convention; two were from PNNA members. Tom Sheehan entered an exhibit of New York stock exchange and related medals (winning second place in the "local interest" class), and Ken Hill entered an exhibit of US gold coins with die varieties (winning first place in the US gold class). PNNA officers or members Ken Hill, Scott Loos, Tom Sheehan, and Joe Boling served as judges in New York.

Exhibits at the PNNA Convention

Now is the time to build your exhibits for next spring's PNNA convention in Seattle. There are also opportunities to show exhibits at the Everett show (November) and the Boeing show (January); use these shows as proving grounds for your April entries. Don't forget that the best exhibitor at the PNNA convention earns \$200 toward the expense of taking the winning exhibit to the ANA convention in the same year (the ANA will be in Baltimore in 2003). Any club that wants a program on exhibit-building should contact the PNNA secretary at the address/phone in the masthead.

Exhibits at the ANA 2003 Spring Convention

The ANA early spring convention (National Money Show™) in 2003 will be in Charlotte, North Carolina. The dates are 21-24 March (Friday-Monday). If you are interested in exhibiting there, write to ANA headquarters (attention Rachel Irish) and request the exhibit rules and application. The case limit for spring shows is completely different from summer shows (up to fifteen cases if you show only one exhibit), which provides an opportunity to show the large exhibit you have always had in the back of your mind.

Editorial: "Liberty" by Joseph Kleinman

As I write this submission to our newsletter on this 11th day of September, I can't help but think about the events of last year and what it may mean for us today. However, before I continue I should like to request that nobody reading this believe a word I say. I make that request because most of what I say will be my opinion and mine alone.

What happened last year was an attack upon our Western Civilization. On that day the target for that multiple attack was our financial markets as well as our military establishment and the offices of our representative government. More specifically, it was an attack upon our liberty.

I submit that our prosperity and our freedoms stem from our Greek and Roman heritage and their profound understanding and love of liberty. So much so that wars were often fought to protect it or to secure it.

The coin illustrated is a Roman Republican coin celebrating the conclusion of a war, which they lost. We call that war The Social War. It's a strange name for a war I think you will agree. The Italian States under Roman Rule fought it for political equality. The Roman Tribune Livius Drusus took up the cause of those states but his murder in 91 BC put an end to their hopes and the war began.

The Italians organized themselves into a confederacy called Italia and raised a huge army which inflicted a number of defeats upon The Roman forces. Eventually, the Romans relented and passed the Lex Julia in 90 BC. The provisions of this law granted Roman Citizenship to any free Italian who applied. The coin was struck in 75 BC by the Moneyer, Farsuleius Mensor as a special issue by the consent of the Senate as the SC on the obverse indicates. On the obverse is the female bust of Liberty with a Liberty Cap behind. The reverse shows a Roman Soldier assisting an Italian wearing a Toga into his chariot. The results of that war and the law it established created the possibility for a stronger and greater Rome. That Rome which would become the blueprint for our own American Nation whose coinage proclaims Liberty.



Minutes of PNNA board meeting

7 September 2002, Portland, Oregon

The meeting was called to order by President Scott Loos at 5:10 PM. Present were vice president Larry Gaye, secretary/treasurer Joseph Boling, directors Richard Billings, William Henderson, Eric Holcomb, Lisa Loos, William Roark, Kathy Rowe, and Larry Rowe, and member Bert Simmons.

Moved and seconded (L Rowe/Billings) to approve the minutes of the board meeting of 4 May as published. Passed. Moved and seconded (L Rowe/Billings) to approve the minutes of the general membership meeting of 4 May as published. Passed. Treasurer Boling presented the monthly financial reports for August 2002. Moved/seconded (Billings/L Rowe) to accept the treasurer's report subject to audit. Passed.

YN committee report. Fifty YN's participated in various YN activities at the PNNA convention in Tukwila. Twenty-one classrooms participated in the quarter design contest. We are now set up at Puyallup with several kinds of handouts for YN's who visit there. Scott Loos requested that the YN promotion fund be replenished for the new school year. A discussion of the appropriate amount hinged on the fact that only \$700 was spent in the first year (of \$1000 appropriated). Since we started the program late in the 2001/2 school year, we might want to appropriate the same amount as last year to add to the residue of \$300 from last year. Moved/seconded (L Loos/Roark) to appropriate another \$1000. Passed.

Show committee reports. We made \$6,936.60 on the 2002 convention. So far this year we have sold 87 tables (of 99 available) for 2003. Billings reports that Tukwila is anxious for us to return for future conventions. S Loos reports that a few hundred dollars will be needed for lamps for the 2003 convention (and that some were not returned intact after the 2002 convention). Moved/seconded (Billings/Gaye) to appropriate \$750 for new lamps, lamp stands, and additional table covers. Gaye suggested using plastic sheeting, which is recyclable for future conventions, rather than fabric for table covers. Gaye also suggests that C-clamps can work as well for light stands, for a lot less money. Passed.

Kathy Rowe suggested that the security officers at the convention should not be out in the hallway conversing, but on the floor with their eyes open. Also, two or three board members do a lot of the work (especially at set-up and tear-down time); more board

members should be involved in helping at these phases of the convention. A certain dealer complained that he was being stolen from, but he tends to not watch his table, preferring to be out cruising the floor. Billings said that nobody had asked to be compensated for losses. S Loos and others observed that the bourse application has verbiage absolving the PNNA of responsibility for watching or securing merchandise. L Rowe said that if there are larcenous people on the floor, unwatched tables are a golden opportunity. Billings said that if a security guard is observed shirking, tell him and he will speak to the officers. Roark mentioned that board members could be used to babysit tables for a few minutes. Simmons said that there was a problem in Spokane with guards shopping; the show staff read them the riot act and straightened that out.

S Loos observed that the current policy of calling for a local club to host the convention is not working; clubs have conflicts of interest with their own shows, or don't want the hassle. He suggests that we retain control of the convention at the PNNA level with our own management, gradually making it a major national show. In lieu of a host club, he proposes hiring a local club to run registration, assist in setup/teardown, etc, to the tune of several hundred dollars. We would have to make an open call for applications in order to give all interested organizations an opportunity to apply. Boling observed that there is no host club requirement in the bylaws; no amendment is required to stop using host clubs. He suggested that action at the board level is not needed to hire assistance for the show; the show committee should make these decisions. L Rowe suggested that service clubs/Scouts might also be offered this opportunity. Billings proposed that PNNA member clubs should have priority, but lacking applicants, we could then go to service organizations. No motion was presented.

Simmons inquired about attendance; over 1000 in 2002. Attributed to what? Better advertising, printed publicity, and selection of places to advertise (which cost us \$3,100 in 2002).

Education: S Loos — what do we want to do in next year or two? He proposed that we spend some of our assets of over \$25,000 in unencumbered funds to promote numismatics. A seminar? Counterfeit seminars have been popular. We could do educational forums (with multiple speakers), or one each in spring and fall on contrasting topics. These would not be associated with the convention. These would be multi-day educational events, but we could also have single-day multi-speaker events. President Loos appointed Larry

Gaye and Lisa Loos as a committee to report in January at the Boeing show board meeting on the possibilities of holding a seminar (topic to be determined) in the fall of 2003. Moved and seconded (K Rowe/L Loos) to conduct such a seminar, and to appropriate \$500 for initial expenses. Passed. Volunteers?

Additional ideas: Dave Schmidt has proposed that PNNA sponsor a club president's breakfast at the spring convention, to get club officers talking to each other and exchanging ideas. We could also have scholarships to the ANA summer seminar, for adults or YN's (or partial scholarships).

Roark suggested that loading and unloading at the spring convention are major problems. We need the large doors open (Loos said that those doors can only be open during selected hours). We will try to block off certain sections for access.

Holcomb suggested that there are judged competitions at the Puyallup fair, as well as peoples' choice ribbons. Can we get competitive exhibits at Puyallup? Boling says that if we can't get more than three exhibitors at the PNNA convention, how can we get more to Puyallup? Gaye says that showing them at Puyallup would let those three (and maybe more in the future) have a wider audience. President Loos appointed Eric Holcomb to check on the feasibility of competitive exhibits at the Fair.

Billings — we should also have signs at Puyallup about the quarter design contest. S Loos — what about a pamphlet of Puget Sound numismatic organizations that can be distributed at Puyallup or other locations? Billings — are we looking for something more eye-catching than the double page sheet that we now distribute? Yes, or to use at other places than Puyallup. Looking for ways for the PNNA to serve clubs.

Moved/seconded (Holcomb/L Loos) to appropriate \$500 to conduct a president's breakfast at the spring convention, with one member of each member club paid for by the PNNA, and other members paying their own expenses. Passed.

ANA summer seminar scholarship: moved/seconded (Gaye/Roark) to appropriate \$1,000 for a PNNA member to go to the ANA summer seminar, starting in 2003. Passed. We need a committee and criteria: President Loos appointed himself, Kathy Rowe, Lisa Loos, and Larry Gaye to establish criteria, prepare an application form, and make the selection. They were directed to present a report at the next board meeting.

Billings will come up with a sign publicizing the quarter design contest for this year's Puyallup Fair. Holcomb will come up with a way to create a pamphlet for publicity.

S Loos — Gaye proposed promoting joint meetings of clubs, with a special speaker, promoting interactions of clubs, etc. This ties in with the presidents' breakfast. Potential joint meetings could be picnics or potlucks. We will put this to the presidents' breakfast participants for implementation suggestions.

The meeting adjourned at 6:31 PM.

PNNA 2003 Convention Update

The PNNA 2003 Show moves onward and upward! As of September 10, 2002, there were only 8 tables left and, since we expanded the table space from 89 at the 2002 show to 99 for the 2003 show, that means we already have commitments for 91 tables or two more than we had for the entire show earlier this year. I'm not sure whether we're going to be able to bring John and Nancy Wilson back again next year but I plan to see them again next month at the annual Hawaiian Numismatic show in Honolulu and make the invitation.

The Tukwila Community Center has again reaffirmed their commitment to working with us. I think they get almost as excited about the show as we do. And we know that we have lots of enthusiastic support in other areas of the City of Tukwila from the Mayor right on down. We're still working on fine tuning the unloading and loading process along with the security considerations. The PNNA board of directors has also come up with a new proposal for soliciting more active participation by local area coin clubs in the annual PNNA show which holds a lot of promise of sharing some of the burden previously shouldered by PNNA members. Local clubs will be offered a "sponsorship" role which will provide up to a \$750 fee to the club in return for their help in set-up, tear down, registration, etc. It sounds like a "win-win" deal for both the local club and the PNNA, now we'll wait and see what the clubs think. ANA Representative Program

The American Numismatic Association (ANA) Representative Program was recently revamped to nearly double the number of regional coordinators who provide the ANA with a closer connection with its nearly 500 member clubs. The ANA Board of Governors approved the restructuring at its meetings in Jacksonville in March 2002 and directed Governor Patricia Finner, who chairs the program, and ANA Volunteer Administrator Rachel Irish to work with the current 16 regional coordinators to revise the program. "The Board and the headquarters staff is very supportive of the Representative Program," says ANA President John W. Wilson. "We have a great group of people who work hard to promote the Association and the numismatic hobby." Governor Finner says, "We anticipate that with this restructuring, we can improve

the lines of communication between the Board and headquarters staff, and the regional coordinators, district delegates and club representatives. I have been working with Rachel Irish to survey the regional coordinators to assess their needs and seek ways to help them better serve the ANA."

Under the revised mission statement, the ANA Representative Program "is to work directly with collectors and clubs to promote and expand the numismatic experience through the services and programs offered by the Association." The ANA previously had 16 regional coordinators, including one to assist young numismatists and one to serve as a representative on the Internet. With the revision completed this summer, there are 29 regional coordinators, working with Scott and Lisa Loos of North Bend, Washington, who were appointed by President Wilson to serve as national coordinators. Finner says the Board of Governors is examining ways to provide additional funding to the Representative Program, and Wilson notes that regional coordinators will be able to present appreciation awards to district and club representatives who demonstrate dedicated work for the ANA and the program.

Scott Loos appointed Eric Holcomb to serve as Regional Coordinator for Washington and Oregon. Eric is currently reviewing the services and programs offered by the ANA to see how he can best help to fulfill the ANA Representative Program mission statement here in the Pacific Northwest. Eric found that one of the best services now offered to ANA member clubs is free web site hosting! (The only required expense is about \$30/year for domain name registration.) The PNNA web site (www.pnna.org) is hosted by the ANA, as is the Tacoma-Lakewood Coin Club site (tlcc.info), with more to follow! If your ANA member club is not taking advantage of this service, perhaps you should be!

American Numismatic Association News

START SPREADIN' THE NEWS, ANA'S NEW YORK SHOW WAS GREAT! — The ANA World's Fair of Money 2002 in New York City was some kind of wonderful. More than 11,600 people came through the doors of the Marriott Marquis Hotel in Times Square between July 31 and August 4. Hundreds of 25- and 50-year members in the area received special invitations, and more than 200 new members signed up at the convention. The ANA sold nearly 700 of its World Mints Passports, which offered attendees the opportunity to collect coins from 17 countries represented at the show. Dealers were active throughout the convention, as people bought and sold coins, paper money, tokens and medals. ANA Library and Museum Services staffs were busy with author signings, reference help and valuation services.

The United States Bureau of Engraving and Printing's (BEP) \$1 Billion Exhibit, which featured \$100,000 bills, and the U.S. Mint's booth literally took center stage on one of three floors of the 47-floor Marriott Marquis Hotel. Mint Director Henrietta Holsman Fore helped open the show, conducted a forum to gather collector and dealer input, and spent hours signing souvenir cards for visitors. U.S. Treasurer Rosario Marin, who took office a year ago, made her first visit to an ANA convention and spoke along with BEP Director Thomas Ferguson about the coming changes to the nation's paper money.

Superior Galleries of Beverly Hills, California, conducted the five-session ANA auction, which realized nearly \$8 million. Among the nearly 2,660 lots offered, a unique 1878 pattern \$5 gold piece, graded Proof-65 by the Professional Coin Grading Service (PCGS), sold for nearly \$190,000; an 1839 "no drapery" half dollar, graded Proof-63 by PCGS, brought \$115,000; and an 1833 \$2.50 gold coin, graded MS-67 by NGC, realized \$125,000.

At a special ceremony at the ANA Membership Reception on Friday, August 2, noted rare coin collector and sports agent Dwight N. Manley of Newport Beach, California, and his wife, Sahar, contributed a check in the amount of \$250,000 to the ANA Headquarters Renovation Fund. The Association's Library in Colorado Springs, Colorado, has been named in his honor. Also at the Reception, Clifford Mishler, former chairman of the board of Krause Publications, was honored as the 2002 Numismatist of the Year.

The ANA Education Department presented more than 50 hours of free programming during the show and a three-day United States coin grading seminar before the

convention opened. More than 250 young collectors, age 6-18, participated in the popular "Treasure Trivia Game," with each player receiving a "goodie bag" containing various numismatic collectibles, including a Buffalo nickel, Indian Head cent, a State quarter in an NGC holder and a copy of *A Guide Book of United States Coins* (the "Red Book").

ANA BOARD MEMBER BARRY STUPLER JOINS SEARCH FOR CALIFORNIA QUARTER CONCEPT

— ANA Governor Barry Stuppler joined other numismatists, celebrities and California state officials launching a search for the design concept for the state's quarter, to be issued in January 2005. "It was a great beginning to what I think will be a fun and interesting time trying to decide just what will represent California on its coin," says Stuppler, who will be part of the state design commission.

"There were a number of numismatists at the news conference, including ANA members Dwight Manley, Jim Hunt and Lee Kuntz, and I think we understand the problems some of the other states have experienced in the Mint's 50 State Quarter Program that began in 1999. While we recognize the problems of striking a clean design, the need to stack the coins, the flow of the metal and other aspects of coinage, we also recognize that you cannot have more than one or two concepts on the coin to provide a clear representation of the state."

The search began at a news conference in Sacramento, California, on Wednesday, August 14, with first lady Sharon Davis, State Librarian Kevin Starr and film director-actress Penny Marshall, who also is a coin collector. "For four years, our pockets have been filled with quarters from states like Delaware, Kentucky or Georgia," Davis said at a news conference. "Well, now it's California's turn. But before we get to that point, we need a design that embodies the majesty and diverse heritage of the Golden State."

Stuppler says schools and libraries throughout California will be enlisted to solicit design concepts for Governor Grey Davis' state quarter commission. Stuppler anticipates they will receive 20,000 submissions between September 9 and November 9. The commission will cut that number to 20 by January, according to Stuppler. "There are 35 million people living in California with a wide diversity of thoughts and ideas," Stuppler says. "Ideas range from the Gold Rush and the Golden Gate Bridge to the Spanish missions that dot the state and the Hollywood sign. They all represent a part of the state, but which will represent it the best is the question we must answer."
