PNNA Scholarship Program - Beginning with 2003, the PNNA will offer a scholarship to the ANA Summer Seminar in Colorado Springs, CO. The package will include round trip airfare, seminar tuition, and room and board on the campus of The Colorado College (approximate value of \$1,000). The winner will be either an adult or YN collector that is a member of the PNNA and completes an application indicating his/her activities/contributions to the hobby. The applications are being finalized and I am waiting for the seminar brochures to arrive from the ANA. YN "Design a Quarter" Contest - Aimed at the 5th and 6th grade levels, the "Design a Quarter" contest reached 21 classrooms last year. The program, in participation with local coin clubs and collectors, will promote awareness of the 50 States Quarter Program and give the kids an opportunity to submit their designs of what they think should be on our statehood quarters. Clubs will locate teachers/schools/classrooms willing to participate in the program, coordinate the delivery and pickup of quarter design sheets, provide a current statehood quarter for each participating student (additional prizes/materials can be distributed at club's discretion), judge each classroom's submissions to select a classroom winner, and finally submit the winning classroom designs to the PNNA for display and final judging at the PNNA convention in April. The PNNA will provide design sheets/design criteria, provide one silver eagle for the winning design from each participation classroom (limit of two classrooms per club - additional classrooms can be funded at the club's

expense), provide exhibit space for the winning designs at the PNNA convention, and provide the grand prize of a 1/4 ounce gold eagle. Final designs must be submitted to the PNNA no later than April 15, 2003.

Next PNNA Board Meeting

Exhibits at the 2003 PNNA Convention

Exhibits must be in place by noon on Saturday 26 April to be eligible for awards, which will be announced at 4:00 PM. We would prefer to have your exhibits in place on Friday, so that visitors to the convention can view and learn from them. If you want to use PNNA cases, you must send an application to Larry Rowe by 18 April so that those cases can be available. Use the form enclosed to apply for exhibit space and exhibit cases (send to Larry Rowe, PO Box 61621, Vancouver, WA 98666; phone 360-573-9827; email medalman@paclink.com). Remember that the PNNA best of show winner receives \$200 in assistance to take the winning exhibit to the ANA anniversary convention in the same year.

The complete exhibit application is four pages long, just like ANA's. Pages 2-4 are only needed if you intend to have someone else place or remove your exhibit or if you are a multiple winner of first place awards at previous PNNA conventions. If you think you need the last three pages (not included here to save postage), ask for a complete copy of the rules from the secretary at the address in the letterhead. There are several references to specific parts of the rules in the PNNA application; if you have a copy of the ANA rules, you can determine what those references are without having the PNNA rules in hand.

The ANA early spring convention in 2003 will be in Charlotte, NC. The dates are 21-23 March (Friday-Sunday). The case limit for spring shows is completely different from summer shows (up to fifteen cases if you show only one exhibit), which provides an opportunity to show the large exhibit you have always had in the back of your mind. Plus, the best-of-show award this year is a high-grade US double eagle. APPLICATION DEADLINE IS 24 FEBRUARY.

PNNA 2003 Convention Update

The PNNA 2003 Show moves onward and upward! As of December 2002, there were only 3 tables left and, since we expanded the table space from 89 at the 2002 show to 99 for the 2003 show, that means we already have commitments for 96 tables or seven more than we had for the entire show earlier this year.

The Tukwila Community Center has again reaffirmed their commitment to working with us. I think they get almost as excited about the show as we do. And we know that we have lots of enthusiastic support in other areas of the City of Tukwila from the Mayor right on down. We're still working on fine tuning the unloading and loading process along with the security considerations. The PNNA board of directors has also come up with a new proposal for soliciting more active participation by local area coin clubs in the annual PNNA show which holds a lot of promise of sharing some of the burden previously shouldered by PNNA members. Local clubs will be offered a "sponsorship" role which will provide up to a \$750 fee to the club in return for their help in set-up, tear down, registration, etc. It sounds like a "win-win" deal for both the local club and the PNNA, now we'll wait and see what the clubs think. Lesser Deity by Joseph Kleinman

Most of us are familiar with the gods and goddesses of the ancient Greeks and Romans.

We have Zeus (Jupiter to the Romans), Apollo, Venus and so on. However, there were other deities that were also part of the ancient pantheon of gods. The Romans were especially adept at maintaining a variety of these lesser deities, which today we call personifications. A personification is simply a quality, condition or state of being that is presented as a human being. For example, in New York Harbor there is a monument that we call the Statue of Liberty. In the last newsletter I showed an example of that personification on a Silver Denarius. Another example of a personification would be the statue of Justice that often appears on or near a courthouse. The ancients had an abundance of these personifications, which they venerated along with their usual Olympian deities.

On ancient coins personifications were used in order to associate a particular attribute or condition with the person or authority issuing the coin. This was extremely prevalent during the Imperial Period but actually began much earlier in Republican times. Back then there were neither newspapers nor any other means of mass communication. The only medium available to the government was the ability to issue coins. Some of the personifications were male and some female. For example, we have Abundance, Clemency, Concord, Fortune, Joy and Hope shown as female. For the male we have Spirit, Honor, Virtue, Good Outcome and so on. So an emperor wishing to take credit for a victory achieved on the battlefield

might place an inscription on the reverse of a coin reading VICTORIAAVG, the victory of the emperor.

Personifications and the study of them can secure for us a deeper understanding of those distant times and make an excellent basis for an ancient coin collection.

The coin illustrated with this opus is a Roman Republican Silver Denarius of the moneyer M. Herennius. This was an issue struck between 108-107 BC. The obverse shows the personification PIETAS (piety). Piety had a different meaning to the Romans than it does for us. To us it might mean a deeply religious man or woman but to the Romans it meant loyalty, faithfulness to ones family or to the state. The reverse of the coin shows one of the Catanaean Brothers running right and bearing his father on his shoulders. This was to rescue his family from an eruption of Mount Etna. However, there is a far more profound meaning to the reverse because it recalls the foundation story of the Roman People, when Aeneas rescues his father from the burning City of Troy.

American Numismatic Association News

ANA Discontinues Authentication Service – The ANA Authentication Bureau (ANAAB) is no longer accepting submissions for authentication. The ANA Board of Governors voted at a meeting in New York City to discontinue ANAAB after reviewing a report that suggested the cost of employing a full-time authenticator outweighed the benefits to the membership. All recent submissions have been returned. “After a careful examination of ANA’s authentication services and recognizing the declining demand for them over the years, the Board had to make a fiscal decision,” says Lawrence J. Lee, ANA Museum curator who oversaw ANAAB during the past year. “The ANA began authenticating coins 30 years ago as a way to reduce counterfeiting of collector coins. We were very successful in that area. In addition, the ANA has offered classes in counterfeit detection over the years, and scores of people have taken them and are doing well to preserve the integrity of the hobby. “However, most of the coin-grading firms now are offering authentication services to collectors.” Over the next year, the ANA will be re-evaluating its ability to provide authentication services and may, after further study, reinstate ANAAB or another authentication program.

Fall Issue of “Discovery Guide” Now Available - The latest edition of ANA’s “discovery guide” - *The World of Money* - offers more ideas for introducing the joys of coin collecting to the general public, young and emerging collectors, families and educators. “Our first issue last spring was a great success,” says ANA Education Director Gail Baker. “We printed 28,000 copies and distributed them to our junior and student members, as well as clubs. They proved so popular, we decided to issue fall and spring editions, and, because of the interest in our first issue, we have printed 100,000 copies this fall, sending them to all ANA members.”

Presented in a friendly, easy-to-read format, the articles are timely, interesting and fun, and the eight-page, 11 x 17-inch “newspaper” is packed with “Know more!” references to web sites, books and periodicals. The new issue features brief articles on the United States Mint’s 50 State Quarters™ Program, ancient coins, the Roosevelt dime and euros, as well as a two-page feature on “The Tale of the Coin” - short stories on a wide variety of coins, including the Peace dollar, coins from England’s penal colony in Australia and the “\$5 nickel.” The new ANA discovery guide also features an article on the recent “Sing a Song of Sixpence” ANA Museum exhibit and information about educational programs offered by the Association.

“The ANA discovery guide is a great publication to help introduce prospective collectors to numismatics,” Baker

says. “It also is the perfect give away for the National Open House we are suggesting clubs conduct for National Coin Week (April 20-26, 2003).” To receive a sample copy, send a large, self-addressed, 74-cent stamped envelope to: ANA Education Department, 818 N. “RENDEZVOUS WITH DESTINY: THE MONEY OF WWII” - On December 7, 2002 - 61 years after the United States was thrust into the greatest global conflict in the history of mankind - the ANA Museum will open “Rendezvous with Destiny: The Money of WWII.” This new exhibit will fill the 5,000-square-foot main gallery of the Museum at 818 North Cascade Avenue in Colorado Springs.

Money is the engine that drives war. Whether minted from gold, silver or copper, or formed from stone, paper or cloth, money was a major player on all sides of World War II. Regardless of its form or denomination - dollars, francs, lire, marks, pounds, rubles or yen - money was raised to finance war machines, counterfeited to destroy economies and fashioned to sustain lives. Today, it is a reflection of the people and nations that made and used it during those dark years of conflict.

This comprehensive exhibit at the Museum showcases coins, currency and artifacts from that great, global conflict. Examples are included from the European Theatre, the Pacific Theatre, and from the Home Front.

Nominations for Board of Governors – Nominations for candidates to the ANA Board of Governors will be accepted beginning December 1, 2002. The ANA is a nonprofit, educational organization governed by a nine-member Board, which includes a president, vice president and seven governors at large. The ANA’s federal charter rests control of the Association in the hands of this Board.

In 2003 the terms of all nine officers will expire. Those elected will be installed on August 2, 2003, at the ANA’s 112th Anniversary Convention in Baltimore, Maryland, and will compose the Board of Governors for the ensuing two years. ANA members with voting privileges can nominate candidates for the ANA Board of Governors. Nominations must be in writing and received by the executive director no later than March 31, 2003. To be a candidate for office, a member must receive at least five (5) nominations from member clubs in good standing and at least five (5) nominations from individual members in good standing. No member may nominate himself or herself for office.
