Fall Convention Dates/Times/Info

Well here we are again, the 6th Annual Willamette-PNNA coin show is on track to open to the public, October 23-24, 2010. This has been a very successful show in the Northwest thanks to the hard work of Scott and Lisa Loos as well as the entire Willamette Coin Club.

The show will open to dealers on Friday the 22nd at about 6:00 PM (a bit later than normal) and will run until about 8:00 PM. Early Birders will also be allowed to enter when the dealers enter and may pick up their Early Bird Pass on Friday, which will cover the entire weekend. Setup and Early Bird entry will continue on Saturday morning at 8:00 AM.

The Willamette Coin Club will be offering a free entry to all visitors who take MAX to the venue; the \$2.00 entry fee will be waived and they will still receive two free tickets to the hourly drawing, such a deal.

Show hours for the public will be: Saturday, October 23rd from 10:00 AM to 6:00 PM, and Sunday from 10:00 AM until 4:00 PM. We hope to see all PNNA/Willamette members there to welcome their fellow collectors.

- There will be an expanded exhibit area on one side of the room near the entrance. Please bring your exhibits even if you didn't contact Larry Rowe in advance (however, cases may be limited). Eric Holcomb will be available to consult.
- Walt Ostromecki will again conduct the popular YN treasure hunt.
- Information on souvenirs is not available at this time, so you'll have to attend the show!
- The hotel room block at the Lloyd Center DoubleTree may be sold out, but there are numerous other hotels within a reasonable distance.

PNNA-Willamette Fall Convention Young Numismatist/ANA Program

In addition to a Boy Scouts clinic, there will also be a youth and family "KID'S ZONE" table inside the show which will provide youth, families and non-collectors with all sorts of FREE hobby introduction information and educational materials. In addition, the Kid's Zone table will sponsor a FREE 11-stop youth educational money-treasure hunt activity. The 'coin treasure' will include a variety of coins attached to informative-educational cards such as: Indian cents, 1943 steel cents, 2010 Lincoln and Union shield cents, old buffalo nickels, US Mint blank planchet/Lincoln cent, foreign currency, latest US National Parks Quarters, etc.

Youth (ages 9 and up) will also have the opportunity to play "Deal or No Deal - the Numismatic version" for taking home one of 22 US prizes, everything from 1, 2, 3 cents to nickels, silver dimes, quarters and halves to the top prize of a silver dollar. A pre-qualification test is required. The subject of this year's quiz deals with foreign currency country identification. Parents are permitted to assist their children in this learning experience.

All FREE Kid's Zone activities/programs will operate during show hours on Saturday and Sunday.

The table will also serve as an ANA information site for members and potential new members. A show special ANA rate of \$18 for new members for the on-line version of *The Numismatist* will be offered by ANA Governor Walt Ostromecki. A special youth rate, for those 23 and under, will be offered at \$5, again for the online *Numismatist*. Ostromecki will also address questions or concerns from the ANA membership and the public on Association matters.

There will also be Boy Scout and Girl Scout clinics on Saturday at the show. Please contact James Reinders (james AT collect3.com) to get more information.

PNNA Board Meeting Minutes

10 July 2010, North Bend, Washington

Members in Attendance: Lisa Loos, President; Danny Bisgaard, Vice President; Michael Labosier, Secretary; Scott Loos, Treasurer; John Enges, Director; Gawain O'Connor, Director; Dale Reubish, Director; Rick Schulz, Director; Dennis Stevens, Director; Dan Vornbrock, Director; Bruce Wonder, Director

Members Absent: Larry Gaye, Past President; Mark Gruner, Director; William McKivor, Director; James Reinders, Director.

Guests in Attendance: None.

The board meeting was called to order by President Lisa Loos at 1:05 p.m. This being the first meeting of the newly elected board, Lisa welcomed the directors and asked them to introduce themselves. Lisa then reviewed the meeting schedule. Board meetings are held four times each year: In January at the annual Boeing club show (Kent, WA), in April or May at the annual spring convention (Tukwila, WA), in July or August (held either in the Seattle or Portland area), and in October at the annual fall convention (Portland, OR).

Secretary's Report: Mike Labosier called for any changes or corrections to the minutes of the April 17, 2010 board and membership meetings as published on the PNNA website and in the Third Quarter 2010 *Nor'wester*. One minor change to the membership meeting minutes was noted, and the minutes were then approved (Scott/Danny). Mike then reported on correspondence received by the club. There were two email offers relating to online calendars that could be used to publicize conventions and shows, and an offer from the Tri-Cities Visitor and Convention Bureau to work with the PNNA on any shows that might be considered in that locale. All three items were referred to the convention committee for further consideration. Mike will order name badges for the new board members and will forward information on how to order the green jackets worn by some board members at PNNA sponsored events.

Treasurer's Report: Scott Loos reviewed the PNNA's financial position as of June 30. Club revenues for first half of 2010 totaled \$36,725, with about \$30,000 of that from convention income. Year-to-date expenses through June were \$30,361, with just under \$23,000 attributable to the Tukwila annual convention. At June 30, the Association's cash balances totaled \$64,760 — mostly invested in CDs and a money market account. Fund balances also totaled \$64,760, with \$53,235 of that in the general fund. The Treasurer's report was accepted by the board (Bruce/Danny).

Lisa next explained the background of the board's committee structure. A list of the committees had been circulated prior to the board meeting, and each member was asked to serve on two committees. The committee assignments and chairperson designations are in the process of being finalized. There followed a general discussion of ideas as to how the committees can best promote the PNNA's mission. Ways to increase interaction between the PNNA and its member clubs and among the clubs themselves were also discussed. Specific comments relating to each committee are noted below.

Education – This committee is charged with arranging seminars and symposiums, as well as recruiting speakers and coordinating Numismatic Theater presentations at the conventions. Scott Loos reported on continuing efforts to arrange a local stand-alone seminar, not scheduled in conjunction with a coin show. A two-day seminar on counterfeit detection, arranged through the ANA and featuring a nationally known expert is under consideration. The board was supportive of that effort and agreed with Scott that scheduling the seminar for the fall of 2010 was probably too soon to promote it properly. Scott will continue to work on plans and timing.

Membership/Awareness – This committee is involved in advertising and other promotional activities to increase the awareness of the PNNA and the benefits of membership. Lisa spearheaded a recent project to produce a new tri-fold promotional flyer to be distributed at local shows.

Convention – The convention committee is responsible for the planning and operation of the spring and fall conventions. Mike Labosier serves as General Chairman of the spring convention in Tukwila; Larry Gaye is General Chairman of the fall convention in Portland. The board discussed convention finances, the possibility of a larger venue for the spring convention, advertising, visitor amenity ideas, and educational program possibilities.

Publications – This committee is responsible for maintaining the PNNA website, publishing and distributing *The Nor'wester*, and printing and distributing the show calendar.

Outreach – The outreach committee coordinates the PNNA's participation at the Puyallup Fair's Hobby Hall, as well as the YN program and other activities promoting interest in numismatics. James Reinders currently heads up the YN program. James sent a report via Rick Schulz requesting \$500 for use on YN program initiatives. The board approved a motion to authorize \$500 in seed money for YN outreach activities at the fall convention in Portland (Scott/Danny). Rick

Schulz has taken charge of Puyallup Fair coordination. The PNNA has long participated in this Seattle area fair, which is the fourth largest in the country. Rick reported that to date, 90% of the four-hour shifts had been filled. Lisa suggested that all board members consider signing up for a shift. There was discussion of other outreach possibilities to increase interaction with and among the member clubs.

Awards/Scholarships – the role of this committee is to ensure that sub-committees for the various PNNA awards and scholarships have selected award winners and prepared the appropriate plaques and awards. Danny Bisgaard, the chairperson for this committee, noted that there were few applicants for the most recently offered scholarships and few nominations for the awards. He described publicity efforts and solicited ideas on how to generate more interest and participation.

Exhibits – The exhibits committee promotes exhibiting at the spring and fall conventions and at other shows, and coordinates exhibit awards. The committee also coordinates exhibiting seminars.

Election — The election committee coordinates the recruitment of candidates for the board and runs the elections. A key objective for this committee continues to be finding ways to increase interest in the election and improve voter turnout.

To get the new committee work underway, Lisa asked that each committee chairperson provide her with a report noting accomplishments and listing bullet points of goals by September 15.

Other Business:

Lisa reported that Al Westerhof and Richard Ripkowski had recently passed away. Mike will send condolence cards on behalf of the PNNA.

Scott reported on a provision of the federal health-care reform legislation that will require all businesses to report to the IRS all payments to individuals or other businesses that total over \$600 in a calendar year, starting January 1, 2012. The payments would be reportable on Forms 1099, currently used to report only payments for services to unincorporated entities. Coin dealers would be subject to the new reporting requirement, which would apply to all vendor payments. The new rule would be a significant administrative burden to dealers. There has been considerable coverage of this provision recently in the general press, and some legislative moves for repeal. Dealers should stay tuned for further news on this topic.

There being no further business, the meeting was adjourned at 3:05 p.m.
