The Board meeting was called to order by President Ed at 8:02 a.m., who welcomed the members and guests in attendance. He also thanked everyone for their support.

**Secretary's Report:** Motion made by Lisa and seconded by Brian to approve the January 20, 2024, minutes. Approved unanimously. Danny reported on receiving a thank-you card from one of the Summer Seminar scholarship winners.

**Treasurer's Report:** Scott reported total expenses through March 31, 2024, are \$5,069.65 and revenues for the same period are \$28,253.76. Total cash balances are \$82,231.94. Expenses and revenues of the convention make up most of the report. Motion made by Danny and seconded by Mark to approve the Treasurer's report. Approved unanimously.

#### **Committee Reports:**

**Conventions** – Ed reported 500 participants on Friday. 10 early birds. Scott reported the Fall Show is set for October 4-6, 2024. Continue to work with facility on replacing the white chairs that tend to break. Kevin reported additional garbage bags will be here on Saturday. Scott reported bourse was sold out and a waiting list was used to replace dealers that did not return bourse applications in a timely manner. Danny reported that at least three dealers were cut by exposed staples at the tables. Next year will be a quality control issue to make sure staples are not exposed. Danny mailed out 2,700 postcards to past attendees. We continue to look at ways to minimize postage on this mailing.

**Exhibits** – James R. and Eric reported seven exhibits, three to be judged in three different classes. Eric to advise regarding the People's Choice voting result at the end of the show. Prizes to be mailed in the future by Danny.

**Membership** – Danny reported on the continued process of getting dues paid in a timely manner. Lisa reported she signed up two life members. Steve suggested not deleting all the information on a

member, make sure you keep the e-mail portion of the name. Lisa to mail letter and ribbons to Life Members reminding them that they can get into the show early. Danny to provide Life Member list to Lisa.

**Outreach** – Tony and James R. are running the scout merit badge program; 29 scouts have signed up. Additional room to be used. Rick reported that the signup sheet for the Puyallup Fair is on the website. Will update when Eric gets back from his eclipse adventure. Never enough volunteers.

**Dealers** – No report.

**Awards** – Danny reported awards have been finalized for this evening's meeting. We had nominations for each category and submissions for the literary and newsletter awards. Ed has two Presidential Awards. We also awarded two Summer Seminar scholarships, one adult and one Y/N. Both winners have been advised to submit an article about their experiences for *The Nor'wester*.

**Publications** – Danny and Rick continue to receive *Nor'westers* and calendars. Danny delivered 500 *Nor'westers* for distribution at the show and to Rick for distribution to the clubs and Puyallup Fair. A box of 100 was given to Ed for the Boise, Idaho show set for May. Eric produced additional calendars for the show which Danny delivered to the show.

**Education** – Tony to oversee the treasure hunt. Scott advised may have another token class in the future, but costs may outweigh the benefits.

**Election** – Danny reported eight mail-in ballots received and nine online ballots received. Results to be announced at this evening's Membership Meeting.

**Show Security** – Kevin has no report and requested this agenda item be deleted in the future. Dan V. did a report on making sure we always have two people at the end of the show to escort late dealers off the floor.

## **Committee Reports:**

**Conventions** – Kevin reported on attendance: Friday 253 (194 paid), Saturday 357 (283 paid). 98 total Facebook ads had been used. Est. 15 Early Birds. Discussed needed edits to the registration cards, i.e., eliminate questions and ask if they want ads mailed or emailed. Motion by Danny and seconded by Brian to print a new batch of 10,000 registration cards with the discussed edits. Scott reported on lighter foot traffic and sales.

**Exhibits** – Eric reported on no competitive exhibits entered. Eric hopes there will be exhibits and awards during next year's spring convention.

**Membership** – Jim Bard has no report but assumes no planned dues increases. Rick reported on one new member sign-up. Danny reported on contacting new and old dealers to update membership database. **Outreach** – James R. reported on seven scouts who earned their merit badges. Appreciated staff locating the room. Future seminars are to be held in Portland and next spring. James to produce a scout generic flyer.

Rick and Kevin reported on the Washington State (Puyallup) Fair. Attendance down; over 8,000 birth year squished pennies were handed out. Eric to publish the location (of the Hobby Hall) on the webpage. The duties this year were split between Rick, Kevin and Brian.

**Dealers** – No report.

**Awards** – Danny asked for more award nominations. Rick agreed. Ray asked for better information on the history of the awards. Danny to contact Joe Boling to get the historical perspective. Rick asked that each Board member come up with a nomination. Danny reported he will get the committee together to go over current awards and maybe have suggestions for new ones.

**Publications** – Danny and Rick continue to receive *Nor'westers* and calendars. Danny delivered *Nor'westers* and calendars to Rick. Eric reported on the increase publishing cost of the two-per-year color convention copy. Estimated costs are \$1,789 for 800 copies. Options are as follows: No change, one color edition per year, or reduce number of copies. Eric reported that the publication is not fully funded by ads. Could increase ad rates and increase the availability of ad space. Board agreed to stay the course based on recommendation by James R. that was seconded by Brian and passed unanimously with one vote abstained. Defer to Boeing show meeting. Continue handing out publications at the show and coin shops. Ray would like to see a stronger bag to be used in carrying publications.

**Education** – Scott reported on hoping Numismatic Theater will be back in the spring. Gawain to coordinate. Need help identifying speakers and staffing for the theater. Ray reported that the Seattle Coin Club has fantastic speakers. Ray will continue his ANA outreach, combining ANA and PNNA education seminars.
